We have early hotel check at the quaint Eureka Inn with a few minutes to relax and freshen up before departing for the Great Passion Play Complex where we'll have an included buffet dinner. We then claim our reserved seats for the Great Passion Play, just as dusk falls around the hills, presented live this evening in the outdoor theater. At the conclusion of the play, we return to our hotel for some restful sleep-hotel for 2 nights. **(D)**

**Wednesday, September 13, 2017:** A hot breakfast will be provided by the hotel before we start our day. Day begins with a drive by of the Christ of the Ozarks Statue before we go onto the Great Passion Play area for our morning tour of the New Holy Land-recreated scenes from the Bible including the Temple in Jerusalem. We'll also have time to visit the Bible Museum and get to see one of only 3 remaining Guttenberg Bibles in existence, plus many others. Next is to the trolley station for quick ride into the downtown area. Lunch is on your own today and you will have time to explore the numerous shops and restaurants in this quaint Arkansas town. Dinner tonight is included at the Forest Hill Restaurant. **(B, D)**

**Thursday, September 14, 2017:** Hot breakfast will be provided again this morning by the hotel! Check out and depart for Bentonville, AR. We will make a stop at the elegant, glass enclosed Thorn Crown Chapel, one of three chapels designed by a world famous architect, E. Faye Jones. Lunch today is on your own. Upon arrival, we'll go to the Crystal Bridges Museum-a gift from one of the Walmart heirs. It is home to some of the finest artwork from around the world by various artists. Tour reservations begin at 1:00 p.m. A secured guided tour of the local Frank Lloyd Wright home also included today. After tours, we claim our hotel rooms for the night at the Hilton Garden Inns Hotel. Dinner tonight is on your own. **(B)**
